This agreement (the "Agreement") is made effective this ___ day of _____, _____ ("Effective Date"), between Bayside Covenant Church, a nonprofit corporation, tax-exempt under Internal Revenue Code § 501(c)(3) ("Bayside"), and _____ ("Sponsor").

To further its tax-exempt purposes, BAYSIDE conducts the following event: **Mexican Fiesta to be held on Friday, February 28, 2020** (the "Program"). The parties have agreed to enter into this Agreement to set forth the terms of Sponsor's non-exclusive sponsorship of the Program in exchange for certain payments to BAYSIDE. Accordingly, BAYSIDE and Sponsor agree as follows:

I. Sponsorship. During the term of this Agreement, BAYSIDE agrees to identify and acknowledge Sponsor as a sponsor of the Program, pursuant to Internal Revenue Code § 513(i) and related Treasury Regulations, by displaying Sponsor's logo and other agreed-upon identifying information on BAYSIDE's marketing, advertising, and promotional media in connection with the Program, in the manner (placement, form, content, etc.) reasonably determined by BAYSIDE in its sole discretion. Sponsor agrees to provide all the necessary content and materials for use in connection with such sponsorship.

II. License of Intellectual Property. Sponsor is the sole owner of all right, title, and interest to all Sponsor information, including Sponsor logos, trademarks, trade names, and copyrighted information, unless otherwise provided. Sponsor hereby grants to BAYSIDE a limited, non-exclusive license to use certain of Sponsor's intellectual property, including names, trademarks, and copyrights (collectively, "Sponsor Property"), solely to identify Sponsor as a sponsor of the Program. It is understood that the Sponsor Property does not and will not violate or infringe upon any patent, copyright, literary, privacy, publicity, trademark, service mark, or any other personal or property right of any third party.

III. Payment Schedule. In consideration for the right to sponsor the Program and to be acknowledged by BAYSIDE as a sponsor of the Program during the term of this Agreement, Sponsor agrees to make a payment to BAYSIDE of \$_____, to be paid in a single lump-sum at commencement of this Agreement. **PLEASE CONSULT WITH YOUR TAX ADVISOR TO DETERMINE HOW MUCH IF ANY OF THIS SPONSORSHIP IS DEDUCTIBLE FOR TAX PURPOSES.**
